The BASE BID work consists of furnishing all labor, materials, equipment, incidentals and taxes to furnish and install approximately 3,800 LF of 15", 18", 24", 30", 36", and/or elliptical equivalent storm sewer piping, 35 ditch bottom inlets, nine (9) stormwater manholes, earthwork, removal of existing concrete ditch paving, driveway removal and replacement, concrete sidewalk, and all necessary restoration. Deductive alternates are included to remove the concrete sidewalk construction and modify the piping materials.
