III-Permit Requirements

1. A valid Town of Lady Lake Business Tax Receipt (if applicable).
 2. Permission Letter from the Property Owner
 3. A site plan showing the proposed location of the vendor.
 4. Documentation of Additional standards (see below)if applicable.
 - 1. All pyrotechnical items sold must be consistent with State laws regulating same and all persons selling pyrotechnical merchandise must be licensed by the State Fire Marshall
 - 2.The location and sales of proposed sale of pyrotechnical items must be approved by the County Fire Marshall.
 - 3. Electrical hook-up or fixtures shall meet the Town's adopted National Electrical Code.

IV-Criteria for Review

-
1. That the temporary use permit is compatible with the various provisions of this chapter.
 2. That the temporary use is a reasonable use of land compatible with the land use designation and zoning classification.
 3. That the temporary use will not impede the reasonable use of land or the orderly development of land in the immediate vicinity
 4. The temporary use will not adversely affect the adjacent uses, buildings or other structures.
 6. Provisions for adequate traffic access/circulation, off-street parking and pedestrian safety have been provided and will be maintained during the operation of the use or activity.
 7. That the granting of the temporary use permit is made subject to those conditions necessary to preserve the general welfare, not the individual welfare of any particular applicant.
